Request for Payment In Lieu of Transportation: Rural/Special Class**TRANSPORTATION CODE 501: NOTES**

Student has impaired mobility and requires transportation on a specially equipped school bus or vehicle used to transport disabled passengers under the authority of the Taxicab Board.

Included are vehicles that meet CSA-D409 or modified CSA-D409 standards (Motor Vehicles for the Transportation of Persons with Physical Disabilities).

Please note that vans with a lift or ramp and a 4-point wheelchair tie-down and occupant restraint system that do not meet CSA-D409 or modified CSA-D409 standards are not eligible.

GENERAL INFORMATION

Payment is made based on the current Manitoba Education Allowance grant standards.

Payments may be pro-rated depending on the frequency of parent-provided transportation and/or transportation on a school bus.

Forms must be completed prior to **June 1** of the current school year.

Students must have an approved Request for Transportation form in order to be considered for payment in lieu of
