## THE WESTERN SCHOOL DIVISION BOARD BY-LAW 03-24

### **Boundaries, Wards and Trustee Representation**

**BEING** A By-Law of the Western School Division to designate wards within its legal boundaries and Trustee representation for them.

**WHEREBY**, the boundaries of the Western School Division shall be the boundary of the area contained in the wards of the Division Administrative Plan of the Western School Division filed in the office of the Director of Surveys at Winnipeg as Plan No. 20553 and the Board of Trustees be composed of a total of five Trustees.

**NOW THEREFORE BE IT ENACTED** as a By-Law of the Western School Division:
