## **Application Process**

Step 1: Complete the application form. A complete application must include the following items:

**Step 3**: A Skype interview will take place between the Program Coordinator and the student to assess the student's level of English and his/her ability to hold a conversation in English. The Skype interview is also an opportunity to get to know the student better and to answer any questions students or parents might have.



**Step 4**: The Coordinator will decide upon acceptance and placement of the student based of the application, availability of homestay families, and openings available at the school. Students will receive a formal letter of acceptance. A minimum payment of \$1000.00 (Canadian) must be sent by the student as soon as he/she receives the letter of acceptance. The full fee may also be paid at this time.

**Step 5**: The student will receive an information package from the Coordinator. The Homestay Coordinator will arrange for the home-stay family and will answer any questions.

**Step 6**: The host family or the coordinator will meet the student at the airport and will help with all practical matters related to the home-stay family and settling in.

**Step 7**: The Coordinator will introduce the student to teachers, counselors, and principals of the receiving school. School officials will ensure that a proper program is planned for the new student.

## TERMS, CONDITIONS, AND HOMESTAY GUIDELINES FOR STUDYING IN THE WESTERN SCHOOL DIVISION

#### 1. BEHAVIOUR

All international students are expected to follow the Western School Division policies in order to support a safe, secure, and positive learning environment. Note that bullying of any form, including physical, sexual, mental, verbal, or written abuse, is unacceptable. At Western School Division, we value self-respect, respect for others, and respect for property. Students should show this behaviour in all school situations including the classroom, field trips, sporting events, and assemblies.

#### 2. KEEP THE LAW

Abiding by the Canadian law is mandatory. Any international student who breaks the law may be removed from the program and may be sent home immediately. Students and/or their parents are expected to cover all travel costs if the student is sent home before completing the program.

#### 3. WEAPONS

All weapons or recreational objects that could be used as weapons such as guns, knives, air guns, paintballs, slingshots, etc. are strictly prohibited in school. Students who break this rule will be suspended and may be expelled from school and the program, and sent home. Students and/or their parents are expected to cover all travel costs if the student is sent home due to misconduct prior to completing the program.

## 4. SMOKING

Although in Canada cigarettes, cigars, and other tobacco products are not illicit, the Western School Division strongly encourages international students to avoid smoking while enrolled in the program. If a student smokes in his/her home country, we highly encourage the student to quit smoking prior to coming to Canada as it is illegal for minors (under 18) to buy tobacco products. Students are NOT allowed to smoke in any public buildings in Manitoba, including the Western School Division offices and schools. International



students are NOT allowed to smoke in a homestay residence. Failure to comply with these rules may result in students being asked to leave the house or even being disconnected from the program and sent home. Students and/or their parents are expected to cover all travel costs if the student is sent home due to misconduct prior to completing the program.

## 5. ALCOHOL, CANNABBIS AND ILICIT DRUGS

Any use of alcohol, cannabis, or illicit drugs is strictly prohibited and may result in expulsion from the program.

## 6. CELL PHONE/IPAD/COMPUTER USE

Students are encouraged not to bring their phones to school to avoid distraction but if they decide to, students are expected to keep their phones in their bags during classes. Students are expected to use their mobile devices in a positive, respectful manner.

At home, students are expected to follow the family's rules with respect to cell phones and other electronics. The program encourages the host families to ask students to put their electronics away at a designated area (e.g. kitchen or living room) for the night between 9-10 p.m. on school nights (Sunday-Thursday) and between 10-11 p.m. on nights with no school the following day (Friday-Saturday).

## 7. VOLUNTEER WORK/EARNING MONEY

Volunteering in the school and/or in the community is a great way to get involved and to learn the language. Working to earn an income is not allowed while in the program.

## 8. DRIVING

The legal age to drive in Manitoba is 16 years old. However, international students at the Western School Division are not allowed to own, rent, or drive any type of motor vehicle. Students should be cautious when accepting rides from friends and ensure the driver has a valid driver's license and the vehicle is fully insured.



## 9. SPENDING MONEY

International students are responsible for keeping track of their own budget. For security reasons, all international students may open a personal bank account, particularly those students enrolled in the full year program. Students may also bring a travel card from their home country. International students are discouraged to carry large amounts of cash. International students are highly discouraged to lend or borrow money from homestay family members or other students.

#### **10. SCHOOL ATTENDANCE**

Regular school attendance is expected of all students participating in the International Student Program. Either a note or a phone call from the homestay family must be provided in case of absences. Unexcused absences will be reported to the homestay family. Excessive absences may result in loss of credit or expulsion from the International Education Program.

#### **11. MAKING SOCIAL PLANS**

While academic study, growth, and development are the principal goals of the International Education Program, group interaction and socializing are also important elements of a successful stay with the program. Students should set aside a regular amount of time each week for leisure activities and relaxation. Much of this time should be with members of the homestay family though activities with school friends are also important. Regardless, all international students should provide **detailed** information to their homestay families as to **where** they are going and **how** they can be reached (i.e. phone number), **when** they will be back, and with **whom** they are going out. Communication with the homestay family is important to prevent confusion and misunderstandings. The homestay family is not expected to "know" where the student(s) will be. They must be informed. If the students are going to be later than they planned, they must contact their homestay family immediately!

Also, students must ask for permission before going out, as opposed to informing their homestay family when they are going out. The homestay family can enforce limits on the amount of socializing the student(s) may do, and the hours of socializing they keep.



## 12. CURFEWS

As a regular member of the homestay family, students are reminded to respect the individual rules of the household. This includes the hours that are spent outside the home. Factors determining this may include: school night vs. weekend; type of activity; and ages of family members in the Homestay. The International Education Program supports a 9:00 p.m. - 10:00 p.m. curfew from Sunday to Thursday and an 11:00 p.m. - 12:00 midnight curfew on Fridays and Saturdays. Students should be reminded to phone if there is a problem. Special arrangements can be made for different circumstances.

#### **13. SLEEPOVERS**

Sleeping over at a friend's house during the week or on weekends is NOT permitted by the International Education Program, as it typically distracts from the learning process. However, there might be cases when homestay families may need to make alternative sleeping arrangements for their student. In such cases, approval must be granted by the International Student Program and details on the student's whereabouts must be furnished.

#### 14. TATTOO AND OR PIERCING

The International Education Program prohibits any of the students enrolled to obtain a tattoo or body piercing during the time they are under the care of Western School Division. Students in violation of this could be removed from the program and sent home.

#### **15. TRAVEL WITH HOMESTAY**

Students are encouraged to explore and experience North American culture through travel during their stay in Morden. However, this travel should not interfere with academic studies and should be limited to designated school holiday periods. A "Parental Permission to Travel" form must be completed and signed by the biological parents for each trip outside the province of Manitoba with or without the homestay family. Special medical insurance must be purchased before traveling outside the province of Manitoba. All students must furnish the International Education Program with a detailed itinerary of their travels including the names and addresses of those they will be traveling with and staying with during their travels. Many homestay families will want to include



the international student in their own travel and holiday plans. Students are encouraged to participate in such travels.

Please note that travel within Manitoba with the host family does not require parental permission but extended trips of more than 2 days need to be reported to the Western School Division's Coordinator of International Education for information in case of emergency. ## 16. TRAVEL (STUDENT MAKING OWN ARRANGEMENTS)

Students wanting to make their own travel arrangements within Manitoba or traveling outside of Manitoba must furnish the International Education Program with a detailed itinerary of their travels including the names and addresses of those they will be traveling with and staying with during their travels signed by their biological parents.

The International Student Program takes no responsibility for student actions taken on travel not approved by the Program. Furthermore, unapproved travel is a serious infraction of International Student Program rules and may result in expulsion from the program.

Travel outside of Canada typically involves securing a visitor's visa to the destination country. Most of these visas require written permission from the International Student Program. Please make arrangements to receive all required documents well in advance of your trip.

## 17. HEALTH CARE

- All International Students will belong to Guard Me Medical Insurance Plan.
- You will receive a Medical Identification Card. Keep with you at all times.
- Some medical services may not be covered (e.g. Holistic practitioners).
- Any extra costs are the students' responsibility.
- For any problems or questions, call the International Student Program Coordinator.



#### 18. VISITORS

Students' family members are permitted to visit them while in Canada. The visit must not interfere with their schooling. The student or family member are responsible to make arrangements for their lodging outside the home of the host family. Students must advise the International Education Program Coordinator at least two weeks prior to their arrival in Canada.

## 19. PERMISSION TO PUBLISH PHOTOGRAPHS AND VIDEOS
